2. Each restricted stock unit represents a contingent right to receive one share of TREE common stock, the cash value thereof or a combination of cash and TREE common stock on the date of settlement, in the Company's discretion.
3. The restricted stock units vest in three equal annual installments beginning July 30, 2019. Vested restricted stock units will be settled in TREE common stock, the cash value thereof or a combination of cash and TREE common stock on the applicable vesting date.
4. The options become exercisable in three equal annual installments beginning July 30, 2019.
